## **6. PRESENTATION:**

### **6.1 Las Virgenes Municipal Water District (LVMWD) Pure Water Project Presentation. (LVMWD General Manager David Pedersen)**

David Pedersen, General Manager, Las Virgenes Municipal Water District presented a PowerPoint presentation and spoke regarding the Pure Water Project. The project was put together through the Las Virgenes/Triunfo Joint Powers Authority.

Mr. Pedersen stated that the Pure Water project was a stakeholder driven process and that the two main reasons for the project were water supply reliability and to meet their regulatory requirements.

Director Bishop asked where the water was coming from and if it was good for drinking. Mr. Pedersen stated that the water was from sewer collection and that after treatment it was good for drinking.

Mr. Pedersen went over the planning phase for the project, training staff on the membrane filtration process.

Chair Dino spoke regarding this item. Assistant Executive Director Heffernan spoke regarding the benefits to the city.

Director Bishop asked what other municipalities were doing this and if grants were used as part of the funding. Mr. Pedersen stated that Orange County's Ground Water Replenishment System, Padre Dam in Santee, and Pure Water San Diego. He also stated that LVMWD/Triunfo did apply for grants for the Pure Water Project.

There was additional discussion regarding the Pure Water Project. The Board thanked Mr. Pedersen for his presentation.

Director Bishop requested that we look into funding for the reuse project.

Director LaMoreaux asked if he could provide an update on the Palmdale Regional augmentation project.
